Will Russia's energy sector be on the SDN list?

While preexisting authorities -- including EO 13662 -- already authorized OFAC to add companies operating in Russia's energy sectors to the SDN List, the EO 14024 Determination confirms that the energy sector will be an area of continued focus for U.S. sanctions implementation.

What are some restrictions imposed on Russia's energy sector?

Such restrictions include, in the energy sector context: A prohibition on provision of services with respect to specified energy projects. An import ban on energy products of Russian origin. A price cap on crude oil and petroleum products of Russian origin.

Are new sanctions targeting Russia's energy industry?

The new sanctions target Russia's energy industry, the Russian government's largest source of revenue. The U.S. Department of the Treasury's Office of Foreign Assets Control ("OFAC") published two new determinations targeting the Russian energy sector.

First, OFAC issued a determination, pursuant to Executive Order 14024, that authorizes the imposition of sanctions on any person--regardless of nationality--determined ...

The Department is also designating a Georgian-Russian oligarch and a Russian Intelligence Services officer to further address the Russian Federation's malign influence abroad.
